- If the Signature on the Proof of Identity or Proof of Address does not match with the Signature on the Subscription Form, the signature should be verified by the bank where the Subscriber holds a bank account.
- In case applicant is unable to sign due to disability, paralysis, or for any other reasons, Power of attorney holder is not allowed to sign on behalf of the Subscriber, such Subscriber should apply be through Aadhaar eKYC service.
- Inconsistent/incomplete applications are liable to be rejected. The Application shall be verified in accordance to the Identity Verification Guidelines issued by Controller of Certifying Authorities of India.

- USB Token is required for generation of DSC. If the Subscriber does not have it, he/she should make arrangement for the same before download.
- For Foreign Subscribers, Identity proof, Address proof and Photo on the Application has to be notarized by the Public Notary of the Subscriber's native country and also either apostilled if the native country is signatory of Hague Convention else it has to be consularized.

VERIFICATION

Mobile Verification: After enrolment, the Subscribers will receive a SMS in their registered mobile number containing Request ID, The Subscriber has to send an SMS from the same Mobile Number to +919664166000 stating "SAFE Request_ID email_ID confirmed" or alternately the Subscribers from their registered mobile number may call toll free number 1800-419-2929 and Select Option 8 between 9 am and 8 pm on Working Days for Digital Signature Approval. For foreign applicant, mobile verification is exempted.

ATTESTATION
